Opportunities were afforded to all officials to file omissions/objections/complaints if any against the list. Accordingly Smt. N.I. Thankamony (Sl. No. 24) has submitted complaint that Smt. Anila George (Sl. No. 23) is her junior and hence her name is to be included as above in the name of Smt. Anila George. The question of restoration of seniority of Smt. N.I. Thankamony has been rejected while finalizing the select list approved by the DPC (H) on 6.6.2002 . Aggrieved by the above decision Smt. N.I. Thankamony has failed RP No. 806/10 in W.P. (C) No. 29363/2001 and its judgment dated 5.10.2010 ordered that the claim of the petitioner for restoration of seniority is left upon to be agitated and a adjudicated in an appropriate proceedings. Based on the above judgment it is requested to Government that the case can be placed before the next DPC (H). Orders from Government in this regards is awaited.

In the circumstances the provisional seniority list of Deputy Director of Education in the General Education Department pertaining to the period from 2.1.2004 to 30.10.2010 published as per the order read as first paper above is hereby finalized and appended to this order subject to the condition that the request for restoration of seniority of Smt. N.I. Thankamony will be reviewed later based on the Government direction/orders awaited.
