ORDER No. IED/38490/07/DPI DATED 07/03/2008

As per the references cited, requests from the parents of children with disabilities are received for sanctioning special concessions to the Children with Disabilities for S.S.L.C. examination on March 2008 to the following candidates.

In this circumstance the following concessions are granted to the children with Special Needs noted against each, for S.S.L.C examination March 2008 on the basis of Medical Certificate and with the recommendation of the DEOs concerned. The Secretary, Pareeksha Bhavan will inform the Chief Superintendent of concerned examination centers to provide the special privileges granted to the children with Special Needs in tune with the Persons with Disabilities Act 1995. The concerned District Educational Officers will arrange the service of the interpreter and the scribe. The Scribes appointed for the purpose should be persons who do not possess qualifications higher than the examination for which they are appointed. The District Educational Officer will arrange the service of Resource Teacher working under the scheme of IED or specially qualified persons with concerned area of disability as Interpreter. In the absence of the above persons, regular school teachers can also be considered as Interpreters.

Concession granted should be noted on the *Facing Sheet of the Main Answer Book* of each such candidate in **RED INK** by the Chief Superintendent of the examination center with full Signature without fail.

This Order will also be applicable for S.S.L.C. SAY 2008 Examination also.

The Interpreters are eligible for Remuneration and T.A. as to the Invigilator of S.S.L.C. Examination. The person who are appointed as Scribes are eligible for Remuneration as per Order No. Go. (P) 412/69/Edn. Dated 3rd November 1969.
