**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Government have notified Kerala Right of Children to Free and Compulsory Education Rules 2011. The 2012 Amendment to the Right of Children to Free and Compulsory Education Act 2009 by Government of India has incorporated a broader view of the rights of children. Hence RTE Rules 2011 need to be substantially modified in view of the amendment to RTE Act and after considering the Lida Jacob Commission Report and the Comprehensive Educational Package introduced by Government.

In the Circumstances, Government are pleased to constitute a Committee with the following officers of General Education Department to examine the whole issue and submit a report suggesting the changes to be made in the RTE Rules, 2011
