ORDER

As per Rule 2(2)(a) Chapter XXXI KER, the qualification prescribed for the post of High School Assistant (Subjects) is a degree in the concerned subject and B Ed/ BT/LT conferred or recognized by the Universities in Kerala.

As per the letter read as 1st paper above, DPI has requested to include BSc.Ed course of Regional Institute of Education, Mysore of NCERT as one of the qualification for the post of High School Assistant (Subjects). As per the letter read as 2nd paper above, the Secretary, Kerala Public Service Commission has requested to issue an executive order as a prelude to the amendment of special rule and to take necessary action to amend the qualification for High School Assistant (Subjects) by incorporating BSc.Ed as one of the qualifications. Representations from various corners have been received in Government requesting to include BSc.Ed course of Regional Institute of Education, Mysore of NCERT as one of the qualification for the post of High School Assistant (Subjects), The Director, SCERT as per letter read as 3rd paper above has informed that those who have studied Chemistry- Botany-Zoology stream and Physics-Chemistry-Mathematics stream for BSc.Ed Course of Regional Institute of Education, Mysore of NCERT

can be considered for appointment to the post of High School Assistant (Natural Science) and High School Assistant (Physical Science/Mathematics) respectively.

Government have examined the matter in detail and hereby order to include BSc.Ed in Chemistry-Botany-Zoology stream as one of the qualification for the post of High School Assistant (Natural Science) and BSc.Ed in Physics-Chemistry-Mathematics stream as one of the qualification for the post of High School Assistant (Physical Science) & High School Assistant (Mathematics).

Director of Public Instruction will forward the necessary amendment proposal for amending KER and formal amendment in KER will be issued separately.
