As per this office proceedings read as 2<sup>nd</sup> paper above, the under mentioned HSAs were promoted to the cadre of HM/AEO and equated categories on Rs. 20740-36140 and posted to the Schools/Offices noted against their names. But they relinquished their right for promotion to the cadre of HM/AEO either permanently or temporarily for the period as noted against their names from the date of order of promotion.
