As per the Government Order read as 1st and 2nd paper above, 1/3rd ratio promotion (Higher Grade) has been ordered in the cadre of Fair Copy Superintendent w.e.f. 01/04/2016 in time scale Rs.35700-75600/-. The existing cadre strength of Fair Copy Superintendent in the department is 17. Based on the provisions contained in the Government Order 5 Fair Copy Superintendents are eligible for Fair Copy Superintendent (Higher Grade). In order to maintain the ratio, 2 Fair Copy Superintendents are to be promoted as Fair Copy Superintendent (Higher Grade).

In the above circumstances 2 seniormost Fair Copy Superintendents of the department are promoted to the cadre of Fair Copy Superintendent (Higher Grade) on time scale Rs. 35700-75600/- w.e.f. the dates mentioned against their names in the list attached with this order. The promotees are eligible for fixation of pay under Rule 28A of Part I KSR. The Controlling Officers are directed to make necessary entries regarding the ratio promotion in the Service Book of the incumbents under proper attestation. The promotion shown in the list is purely provisional and subject to review if found necessary. If anyone is aggrieved of missing with the provisional promotion now effected herein may file their objection/appeal within 30 days from the date of issue of this order.
