**ORDER**

As per letter read as 2nd and 3rd paper above Government have clarified that the Degree and Diploma in Civil Engineering and Architecture Engineering conducted by the Institution of Civil Engineers (India) as per syllabus approved by AICTE also comes under the purview of the order cited 1st above with effect from the academic year 2007-08. On the basis of this clarification several institutions in Kerala have continuing admissions in such courses.

As per para (ii) of Office Memorandum cited 4th above, Government of India has clarified that all those students who are enrolled with the institutions with permanent recognition up to 31-5-2013 would be eligible for consideration in accordance with MHRD Office Memorandum or Order in force pertaining to the course; but the orders would cease to exist with effect from 1-6-2013 in Central Government Jobs.

In the circumstance, Government hereby declared that the recognition/ equivalence granted to the courses as per the letters read as 2nd and 3rd papers above, shall continue only for qualification acquired by students who enrolled with the institutions with permanent recognition up to 31-5-2013, beyond this date such courses/qualifications shall not be considered as equivalent courses/ qualifications.
